Hi Adrian,

in the `/var/www/localhost/htdocs/livingstone/shared/awisnicki` directory you will find the data file `07NLS-MOD5-final8.csv` and the ruby file `LivingstoneRenameDirAndFile.rb`. Both of these need to be moved to the directory above your data set. For the example set I put it in `awisnicki` and ran it there so that it would take all subdirectories under 'for-Frank' and put them into new subdirectory 'out.' To test it out just enter the command:

```
ruby LivingstoneRenameDirAndFile.rb
```

The ruby file will expect the csv file (containing the dir name translations) to be in it's same directory.

When you move both of these files to a new location to process your complete data set, edit the `LivingstoneRenameDirAndFile.rb` to point to the appropriate subdirectory. If you move it to path `'a/b/c'` in order to process directory `'d'` (`/a/b/c/d`) then edit the last line of `LivingstoneRenameDirAndFile.rb` to process the `'d'` directory. e.g. change;

```
godirs("for-Frank",Dir.pwd+"/out",-1)
```

to

```
godirs("d",Dir.pwd+"/out",-1)
```

If you need a more flexible way of specifying directories I can set up a way to do it in the command line but didn't want to put time into it if it is only intended for a single run.

Please let me know how it runs.

I copied all regular sample files to my laptop and wrote a ruby program which I believe does what you want. I tried running it on spacely but had problems. If I list one of the subdirectories I see 'hidden' files.

If I change to Acc.12927.324-3 and do an 'ls -l' I see;
